## ACTIVITY REPORT September 2017- October 2019

All the activities fall under the category of advocacy and policy. I am the chairperson of the Geneva NGO Committee on Ageing, representing ILC GA, since April 2014. I was reelected in 2016 and 2018. According to the NGO Committee's statutes, I will step down in 2020 after completing 6 years in the position of Chair.

I have reported every quarter with all details so this a general summary and highlights of the activities performed:

#### **HUMAN RIGHTS**

The **Human Rights Council** meets three times a year: four weeks in February-March, three weeks in June-July and three weeks in September. I have participated in all sessions. The March session includes, among many issues, a high-level segment and the rights of persons with disabilities and the rights of migrants; The June session includes the rights of women and the September session includes the rights of older persons when the Independent Expert presents her annual thematic report and the reports of her official visits to countries. I have delivered statements on behalf of ILC GA and organized side events on older refugees, violence against older women and on ageism and the rights of older persons with cosponsorships of NGOs, Member States, OHCHR and other UN agencies.

I have also contributed text to several resolutions including the resolution on technical cooperation around the rights of older persons and the resolution renewing the mandate of the Independent Expert (just adopted).

In addition to the HRC, I have participated in other human rights fora and consultations such as the Social forum, the forum on human rights and business, gender and human rights, annual meeting of the Global Alliance of National Human Rights Institutions (GANHRI) and more

#### Meetings with High Commissioner and Deputy High Commissioner

I held meetings with Michelle Bachelet in 2019 and with Kate Gilmore in 2018. Following our meetings, both have been including older persons in their speeches and interventions.

# United Nations Population Fund (UNFPA) and United Nations Economic Commission for Europe (UNECE)

International Commission on Population and Development: I represented older persons at the regional ICPD +25 in Geneva 1-2 October 2018.

Represented Older Persons at the regional SDGs forum in 2017 and 2018.

I was invited by UNFPA to speak in the rights of older persons and elder abuse at a n international forum in Seoul, Korea in 2017.

I participated and co-organised the NGO forum that preceded the regional follow up of MIPAA in Lisbon in September 2017.

Participated at the UNECE WG on Ageing in November 2017 and I am in constant contact with the secretariat of the WG on Ageing.
