Vulnerable residents in fragile residences: An inquiry into tensions of residential care

Registation number: 19-07724S

Czech Science Foundation (Grantová agentura České republiky), 2019-2021, board No. P404

This qualitative sociological research focuses on a specific tension in residential care for people identified as disabled: the tension between care for the residents, enabling them to live their lives as "normally" as possible, and care for the residences, safeguarding their economic and "cultural" worth. In the Czech Republic, the residential institutions are often housed in castles, monasteries or historical villas, which are similarly out-of-shape, fragile and unattached as their inhabitants. And although care for people and maintenance of things might seem to be two completely different and unrelated activities, they go hand-in-hand and cannot be separated. Our research will contribute to the recent turn of social sciences towards interest in materialities and normativities of care. In short, we will analyze a single field of practice as framed by several diverging logics and sets of values, paying attention to how the multiplicity is managed. We also hope that our research will help to improve living and working conditions in residential care facilities.

Project proposal reflects, in the field of long- term care of persons with dementia, the main goal of the National programme of applied research "to asure internationally comparable research for better health of our population and better response to needs of health care system in the Czech Republic". Long-term care of persons with dementia has been internationally recognized as a research priority, this attention has not attracted in the Czech Republic. The goal of the project is to analyze current situation in long-term care of persons with dementia in the Czech Republic, provide ovierview on this topic and comparison with



other European countries. Methods: mixed method research in long-term care institutions (data about patients, care quality, environment, team interactions, stakeholders roles etc.)

Case management as a complex intervention in dementia, its impact on resource utilisation and the quality of life of patients and caregivers

Case management is generally seen as a way to provide efficient, cost-saving person-centred care for people with dementia by connecting together fragmented services. The project's main aim is to explore the use of the case management method in the Czech Republic and selected EU countries, to identify factors which promote and hinder the effectiveness of case management's implementation and to develop efficient model of case management for people with dementia based on evaluation of existing services through detailed case studies.

This project will provide educational solutions in the form of innovative interprofessional learning experiences to tackle stereotyping of dementia care as low skilled and dismantle leadership barriers facing certain disciplines with a predominately female workforce. We aim to create a range of social participatory and practice based learning resources to equip qualified practitioners from all health and social care disciplines to champion improvements to extended palliative dementia care in their workplace and through membership of a facilitated virtual international community of practice.


New technologies: an opportunity or challenge for an aging population?

Summary:

The population of our planet is aging and there is no doubt that we need to face up to this phenomenon. The book Active Gerontology or Aging well is a response to the current situation aiming to help not only experts but also each of us to understand the complex issue of aging and find a good balance both for ourselves and society. The goal of the book is to link theoretical knowledge and clinical practice to create an environment where we can all age well. The book is based

on recommendations of the World Health Organization and the results of the latest empirical studies. It puts this global and theoretical perspective in a unique way into the



context of Czech environment and practice. Both experts and the lay public will come to their own. After all, old age touches each of us. The book is divided into three sections. The first section is devoted to the phenomenon of aging from different perspectives and in a broader context. It breaks down myths, introduces new concepts and contexts and defines the concept of geriatric care. The second section discusses in detail the key issues of aging. For each problem, it describes why and where it comes from, what impacts it has on the everyday life of the elderly and their environment, how we can identify the problem and what measures to take. The section does not forget the carers, who are often neglected and almost always unappreciated. Readers will find lots of examples, real situations and practical tips. The last, third section presents the first tiny pieces of active gerontology in the Czech Republic and examples of good practice. The aim is to show that many problems can be prevented and that even if they appear, they can be meaningfully lived with. Experts from the fields of doctors, geriatricians, academics, philosophers, psychologists, social workers or carers led by Mgr. Kateřina Macháčová, Ph.D., and doc. MUDr. Iva Holmerová, Ph.D., contributed to the contents of this book.
