Mission of the Center

The goal of the CMRI of Ben-Gurion University of the Negev is to promote good quality of life for older people. Our Center's activities focus on promotion of evidence-based ageing-related information, on disseminating knowledge to national and local policymakers, service providers, the professional communities, and to the public, and on mentoring research students.

Older adults in Israel are a unique heterogeneous population comprised of Israeli-born Jews and Arabs, as well as Jewish immigrants from more than a hundred countries including older Holocaust survivors who still make up > 10% of Israel's older persons.

Our Center cooperates with Israeli policymakers and institutions for older people. Our conferences are often organized in collaboration with social organizations and institutions for older adults.

Activities of ILC-Israel

Despite challenging times in a long and terrible war for all involved on both sides of our borders, MCRA and ILC-Israel have been active in research and planning future activities. However, the international meeting that was initially scheduled to take place at BGU late 2024, then early 2025 has been rescheduled to June 2025.

Thanks to a grant by a private foundation in Germany, ILC-Israel is working on a conceptual framework on integrating human rights into health and social care in Israel and plan an international meeting focusing on Age-friendly Cities and Communities (AFCC) in Israel following the WHO framework and the ILC GA

efforts to become a WHO affiliate. The meeting will include a photo exhibition reflecting the active participation of older persons in all aspects of life.

We are also partners in the COST Action Proposal Ageing and climate change from a human rights-based approach.
