The ultimate goal of our research center is to promote quality of life in late life. Our center's activities focus on promotion of evidence-based, aging-related knowledge, on disseminating accumulated and updated knowledge to national and local policymakers, service providers (public and private), the professional/semi-professional communities, and the public, and on mentoring research students – future leaders in aging in academia and various other institutions. ILC Israel is an integral part of Ben-Gurion University's Center for Multidisciplinary Research and Aging. The Center has a total of 18 members –largely professors and medical faculty. The Center encourages multidisciplinary ageing-related research and research collaborations.

Research

Plans for the Next 6 Months

Conference

ILC Israel and The Center for Multidisciplinary Research in Aging (CMRA) organize annual conferences on ageing-related subjects. We are currently in the process of planning our next conference, which will take place at the end of March 2022. The conference is in collaboration with the Active Aging Hub of Ben-Gurion University and will be on the subjects: 1) Balance and physical activity in stroke patients, and recovery of motor and cognitive functions during the sub-acute phase, and 2) Current evidence on whether we are living longer and healthier lives, as well as who lives a healthier and longer life and why. The event will be a 3-day conference, with the third day being dedicated to promoting collaborations among attending researchers for future projects.

Creating a National ILC-Israel Committee

In October 2021, Prof. A. Mark Clarfield, the new president initiated expanding the scope and scale of ILC-Israel by developing a national executive committee for the center, which extends its reach beyond ILC-Israel's institutional home in the Ben-Gurion University to many academic facilities and medical institutions throughout Israel.
