HUMAN RIGHTS

29th session of the Human Rights Council, 15 June-3 July,

To mark World Elder Abuse Awareness Day, we organised a side event on 15 June. The event "Falling Between the Cracks" focused on abuse and violence against older women. It was cosponsored by OHCHR, UNFPA, INPEA, ILC GA, HelpAge International and nine Member States: Argentina, Austria, Brazil, Canada, Israel, Mozambique, Slovenia, Spain and USA.
