# Activities Report 2013/2014

#### Introduction

ILCSA was admitted to the ILC Global Alliance in June 2005. The centre is operated independently within The Albertina and Walter Sisulu Institute of Ageing in Africa (IAA) in the Faculty of Health Sciences at the University of Cape Town (UCT). ILCSA focuses on social and health research, education, advocacy and policy. Its mission is to promote healthy and productive ageing, and to optimise older persons' full participation in society. Dr Monica Ferreira is President of ILCSA and Dr Sebastiana Kalula is the Director.

Dr Kalula is a board member of the iKhaya leXolo Lase Gugulethu, a long-term care facility in an underprivileged community of Cape Town, which advocates for the improvement of care services in facilities for older persons through the SA Care Forum.

He is currently a James Research Fellow in the Oxford Institute of Population Ageing (UK), but in January 2015 will return to South Africa to head up a new gerontology centre at North-West University in Gauteng Province (Johannesburg). ILCSA will partner with the new centre; specifics of the partnership to be provided later. Initial joint projects between the centres will be in care related areas.

Dr Kalula participated in a Joint National Department of Health Policy Workshop on Non-Communicable Disease Indicators, Monitoring, Surveillance and Evaluation, In Pretoria, October 16-17, 2014.
